COMBINED TUITION AND FEES PER CHILD FOR SCHOOL YEAR 2017-2018

The Annual Published Tuition Rate includes all academic fees with the exception of registration and testing fees.

NON-REFUNDABLE FEES – NOT INCLUDED IN TUITION:

Re-Registration Fee Returning Family:	\$150.00 per family
Registration Fee New Family:	\$175.00 per family
Screening:	\$50.00 per child

DISCRETIONARY TUITION REDUCTION:

Active parishioners of the Church who participate in the faith life of the parish by giving fully of their time, talent and treasure and by regularly attending Sunday Mass and Holy Days of Obligation are eligible for a discretionary tuition reduction. This reduction will be divided by child when reflected on your tuition billing statement. Additionally, parishioners with two or more children are eligible for a multi-child discount.

MULTI CHILD DISCOUNTS

Two children enrolled in school: \$1,500 reduction (per family)
Three children enrolled in school: \$2,250 reduction (per family)
Four children enrolled in school: \$3,000 reduction (per family)

FACTS TUITION MANAGEMENT:

Tuition and fees will be managed by FACTS Tuition Management. All families are required to enroll with FACTS for tuition payments. Payments are made through automatic bank draft only. FACTS, allows families to select a payment option that best suits the family financial needs and are given the option to pay the annual tuition in full or to make 11 (eleven) scheduled, monthly payments. FACTS online registration may be accessed through the school website or FACTS Management website www.factsmgt.com. Student registration for school is not considered complete until a payment plan has been established with FACTS.

PAYMENT SCHEDULE:

Tuition will be billed 11 months, July through May on the 1st or the 15th of the month depending on which billing period is chosen when registering with FACTS. If paying tuition in full, the transaction will be debited in July.

DELINQUENT ACCOUNTS:

Tuition is past due if not paid by the contracted due date with FACTS. Children of parents who are “past due” will not be permitted to attend school until the account is brought current. Report cards and final transcripts will not be released if there is an outstanding balance.
